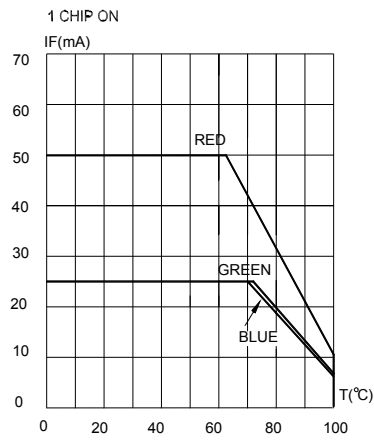
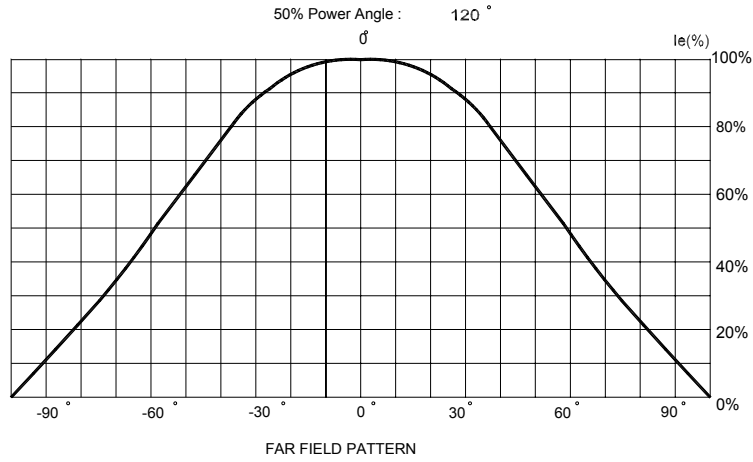
### Important Notes:

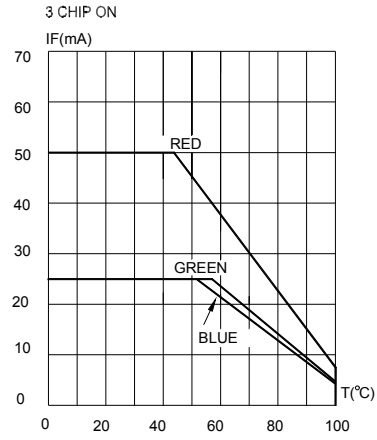

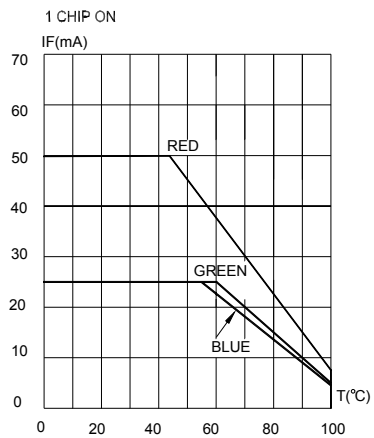

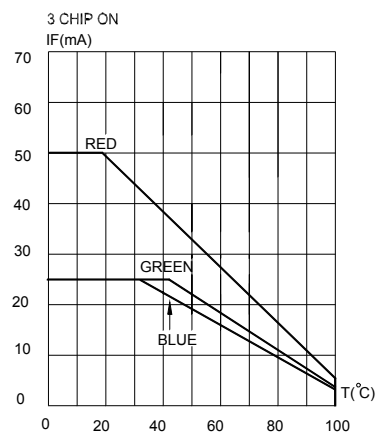
MAXIMUM FORWARD DC CURRENT

VS, SOLDER POINT TEMPERATURE.

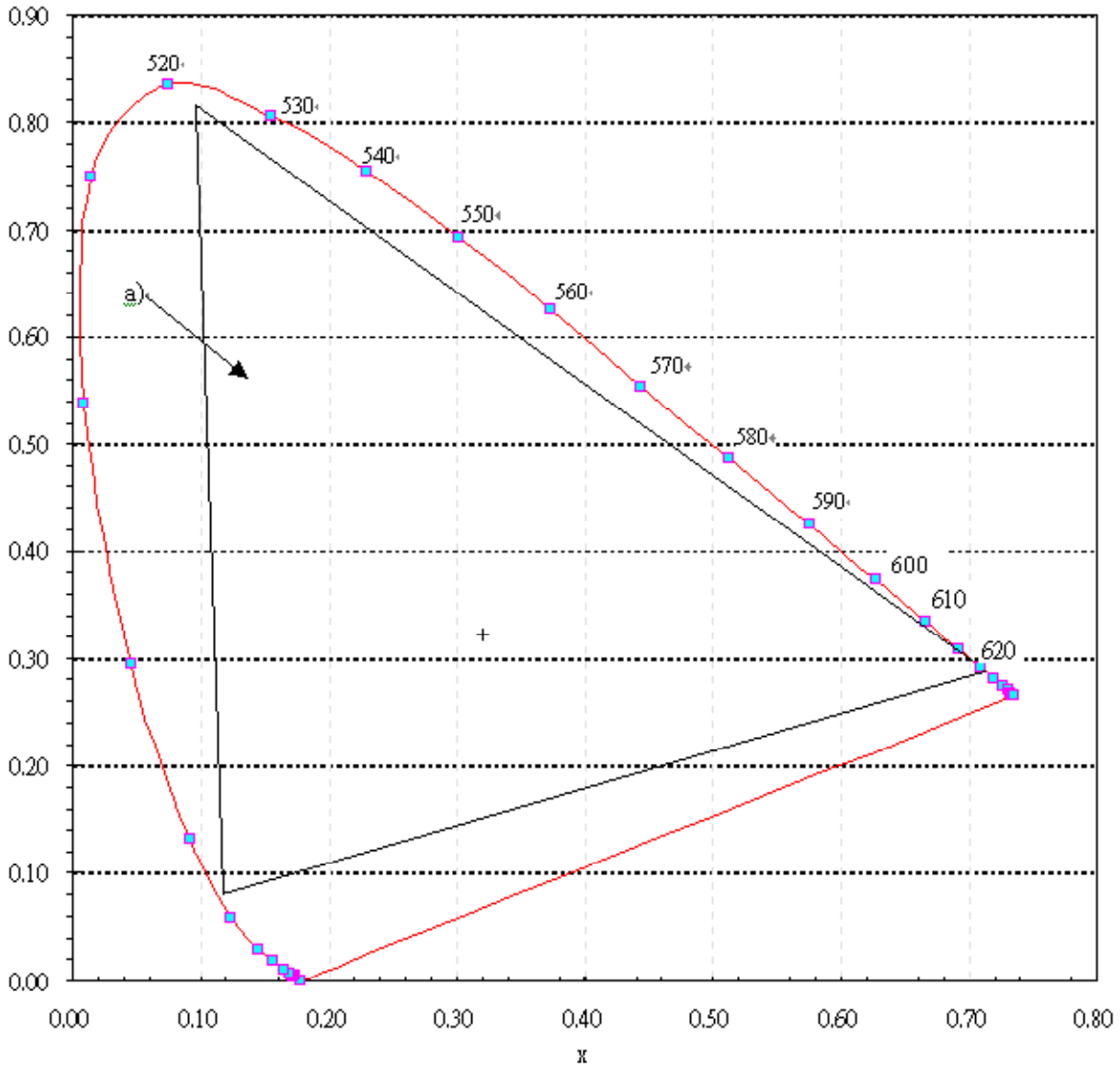


MAXIMUM FORWARD DC CURRENT

VS, AMBIENT TEMPERATURE.

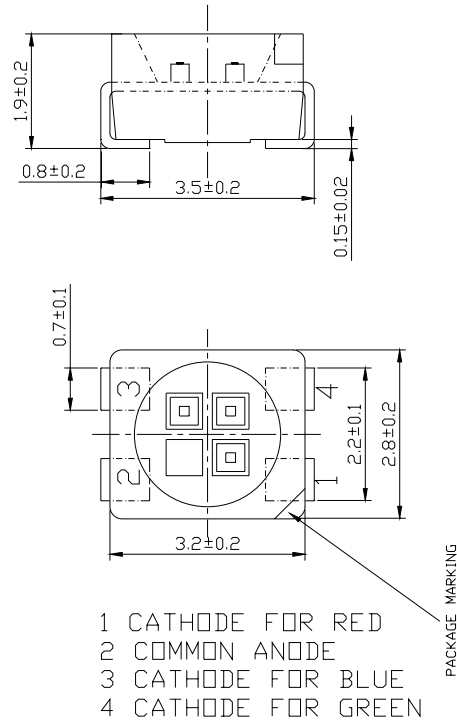
**CIE 1931 Graph**

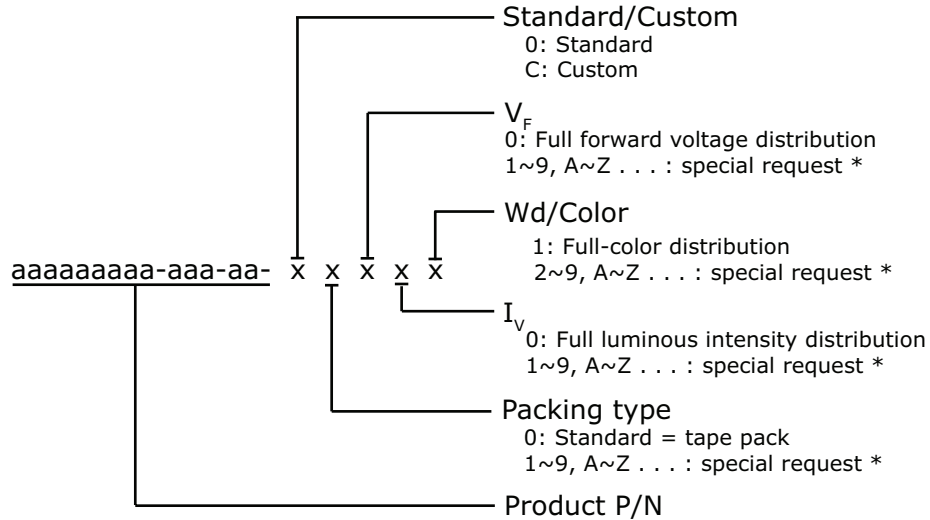
