







Fig. 3 - Typical Junction Capacitance vs. Reverse Voltage





Fig. 5 - Typical Reverse Recovery Time vs. dl_F/dt

Fig. 7 - Typical Stored Charge vs. dI_F/dt




Fig. 6 - Typical Recovery Current vs. $dI_{\mbox{\scriptsize F}}/dt$




Fig. 8 - Typical $dI_{(rec)M}/dt$ vs. dI_F/dt





Fig. 9 - Reverse Recovery Parameter Test Circuit

- Fig. 10 Reverse Recovery Waveform and Definitions


