









Forward Diode Voltage vs. Temp.



On-Resistance vs. Gate-to-Source Voltage












T_C - Case Temperature (°C)

Current Derating*






T_A - Ambient Temperature (°C)




Normalized Thermal Transient Impedance, Junction-to-Ambient
