






Fig. 6.2.1 Switching Time Test Circuit




Fig. 7.1 Marking




Fig. 8.1 I_D - V_{DS}




Fig. 8.3 I_D - V_{GS}




Fig. 8.5 R_{DS(ON)} - I_D




Fig. 8.2 I_D - V_{DS}




Fig. 8.4 V_{DS} - V_{GS}




Fig. 8.6 R_{DS(ON)} - T_a (Note 8)




Fig. 8.7 IDR - VDS




Fig. 8.9 V_{th} - T_a (Note 8)




Fig. 8.11 P_D - T_a (Note 8) (Guaranteed Maximum)




Fig. 8.8 Capacitance - V_{DS}




Fig. 8.10 Dynamic Input/Output Characteristics




Fig. 8.12 P_D - T_c (Note 8) (Guaranteed Maximum)




Fig. 8.13 r_{th} - t_w (Guaranteed Maximum)




Fig. 8.14 Safe Operating Area (Guaranteed Maximum)


