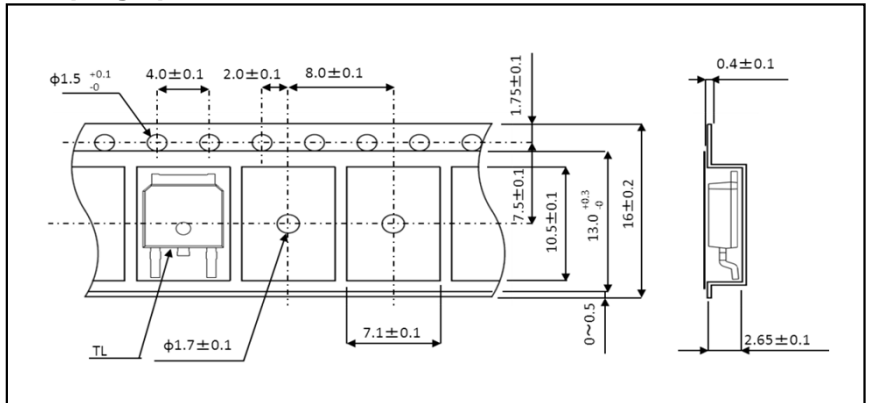

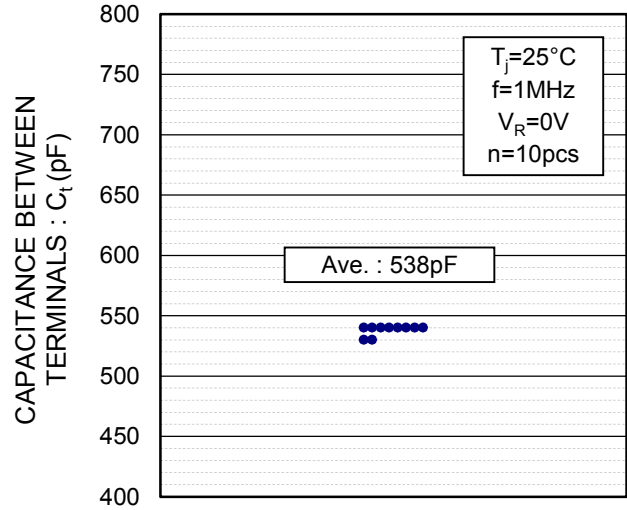
●Electrical Characteristic Curves



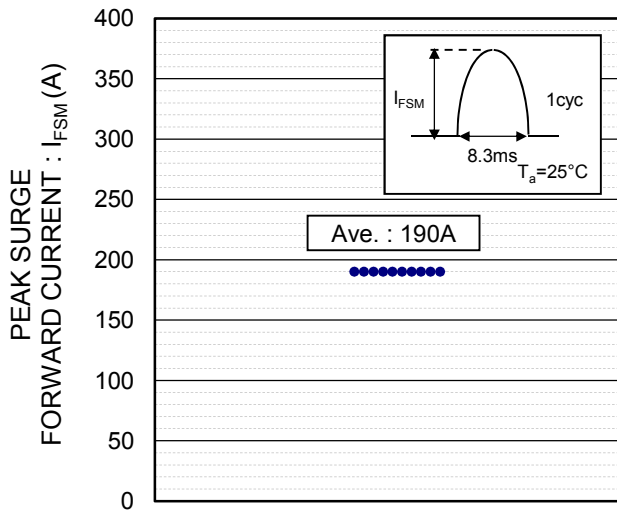
●Electrical Characteristic Curves



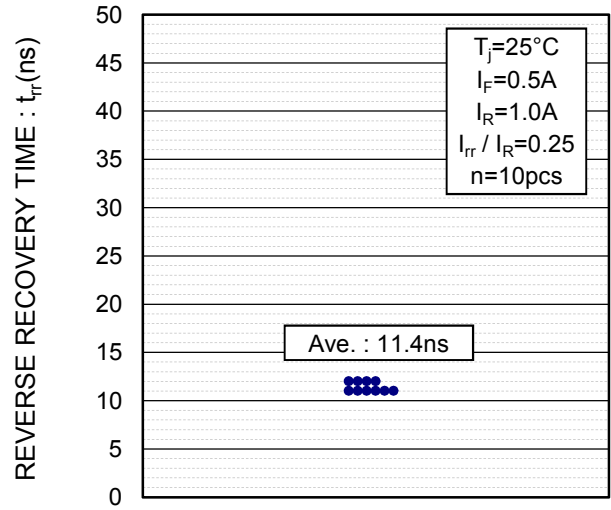
$I_R$  DISPERSION MAP



$C_t$  DISPERSION MAP

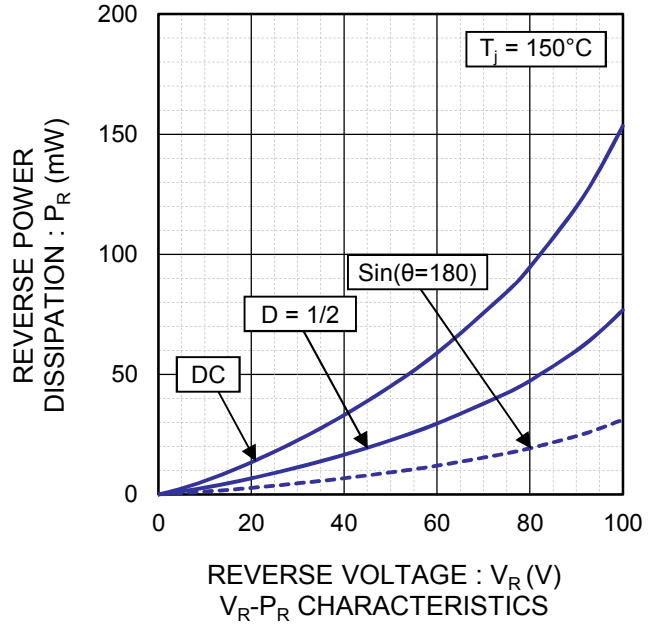
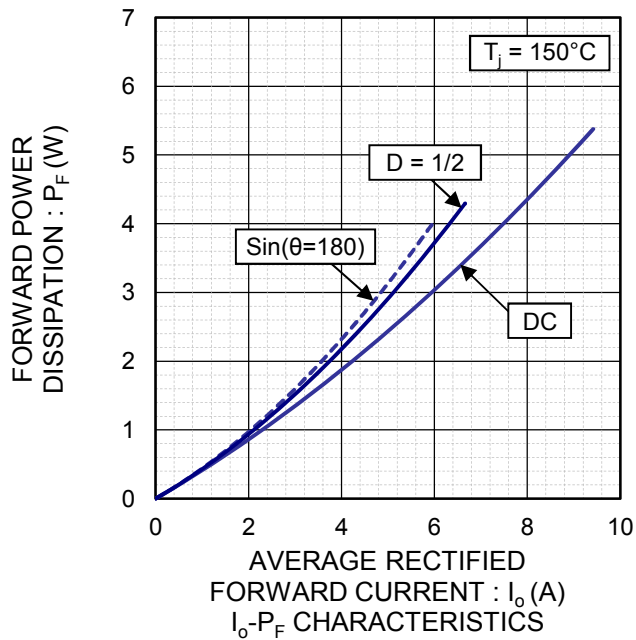
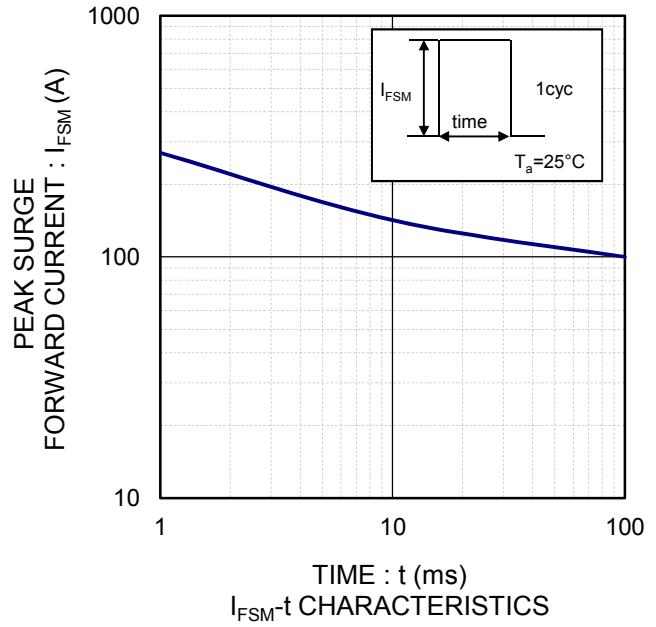
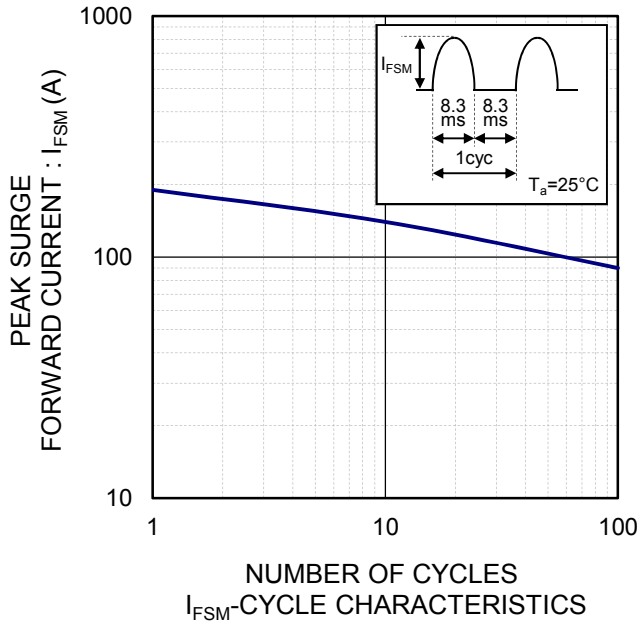


$I_{FSM}$  DISPERSION MAP

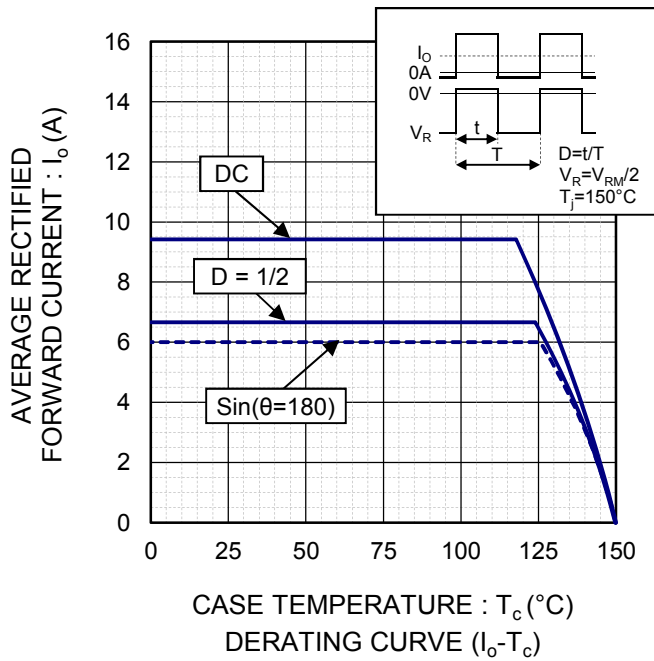
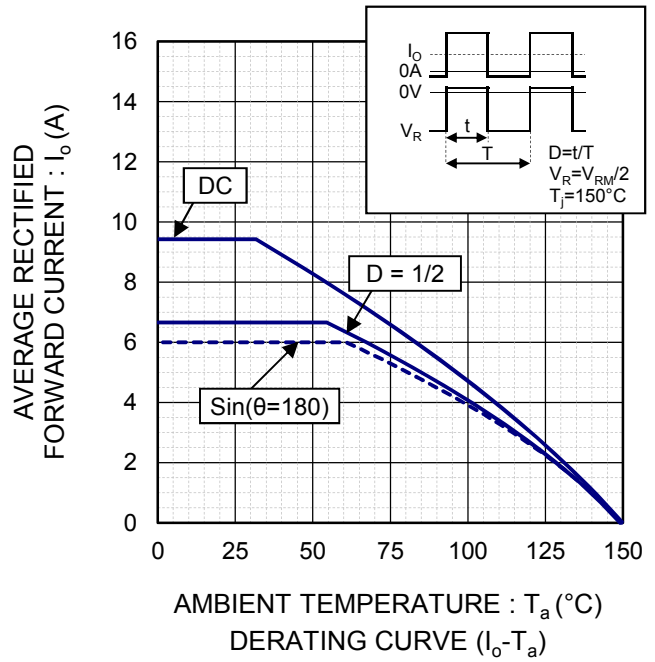
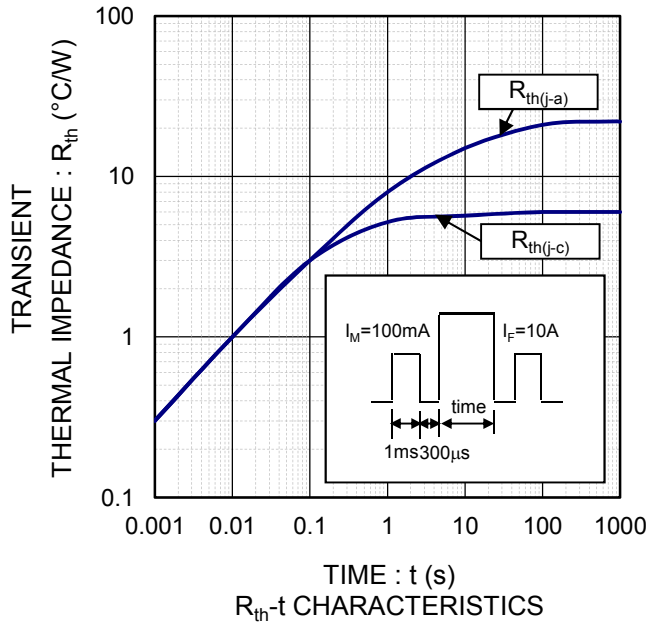


$t_{rr}$  DISPERSION MAP
